GENERAL INFORMATION

ProSolutions 90/10 Surfactant is a superior non-ionic, low-foam surfactant. It acts as a spreader and an activator when used with insecticides, herbicides and fungicides. It is designed for quick wetting, more uniform droplet distribution and increased spray retention on leaf and stem surfaces.

DIRECTIONS FOR USE

Use ½ to 4 pints per 100 gallons of water.

Aerial Application: When applying aerially, follow chemical label directions including a minimum water volume per acre. Do not substitute **ProSolutions 90/10 Surfactant** for water required by the chemical label.

MIXING INSTRUCTIONS

Carefully read and follow directions on the label of the chemical with which **ProSolutions 90/10 Surfactant** is to be used. For local recommendations consult a competent agricultural authority or in absence mix in this order:

1. Dry flowable chemicals
2. Wettable powder chemicals
3. Flowable chemicals
4. Water-soluble chemicals
5. Emulsifiable concentrate chemicals
6. Add **ProSolutions 90/10 Surfactant** and continue agitation

PHYSICAL OR CHEMICAL HAZARDS

Do not use, pour, spill or store near heat or open flame. Use adequate ventilation when handling.

STORAGE AND DISPOSAL

Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse, then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state and federal regulations.
