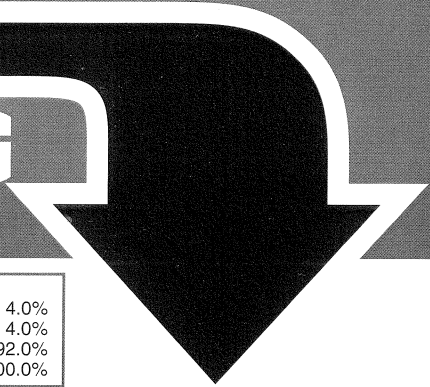

**NON-CROP WEED CONTROL
INDUSTRIAL USE ONLY**

Weed Blast 8-G is a nonselective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is registered for industrial use only such as railroad, utility and highway rights-of-way, and industrial areas. 100 to 200 pound applications of Weed Blast 8-G per acre usually result in a nonproductive condition of the soil for a period of a year or more. The duration of nonproductivity is dependent upon rainfall, soil type, and other conditions. Application with a spoon, a pump-feed backpack spreader or a gravity-feed backpack spreader is prohibited.

Weed Blast 8-G should be applied as furnished with a seed spreader, a fertilizer spreader, or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses, apply Weed Blast 8-G at the rate of 100 to 200 pounds per acre; on smaller plots, 1/4 to 1/2 pound per 100 square feet. Repeat spot treatment may be required when deep rooted perennial weeds are present. The maximum application rate of product that may be applied is no more than 12 lb. ai/A per year or a total of 300 lbs. of product per acre per year. To obtain the best results, Weed Blast 8-G should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Weed Blast 8-G may, however, be applied at any time of the year except when the ground is frozen. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season. Users should consult state agricultural experimental stations or extension service weed specialists for recommendations as to use in their particular area. May not be used to treat berms of ditches, seasonally dry flood plains, deltas, marshes, swamps, bogs, and transitional areas between upland and lowland sites.

Rights-of-Way/Non-Crop Areas:

Maximum rate per application:

- 12.0 pounds diuron active ingredient per acre in areas of high rainfall or dense vegetation.
- 8.0 pounds diuron active ingredient per acre in all other areas.

Apply a maximum of two applications per year.

Minimum retreatment interval: 90 days.

Do not enter or allow others to enter the treated area until dusts have settled.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

IMPORTANT: Do not apply on or near desirable woody or herbaceous plants or on areas where their roots may extend because of possible injury to such plants. Thoroughly clean spreading equipment with a suitable chemical cleaner before using for other purposes (or do not use same spreading equipment for other purposes). Dispose of rinsate according to "Disposal" instructions found under "Storage and Disposal" heading. Do not use on croplands or any land to be used for subsequent cropping. Keep animals off treated areas.
