GENERAL INFORMATION

ELITE PINE AWAY™ is a multifunctional spray adjuvant developed as a penetrating surfactant concentrate and sticker/spreader with wetting, penetrating, and coating characteristics. **ELITE PINE AWAY™** is designed as a replacement for non-ionic surfactants, crop oil concentrates, and methylated seed oils in liquid spray mixtures. **ELITE PINE AWAY™** contains a proprietary agent that bonds the pesticide solution to the crop and decreases the chances of pesticide run-off due to rain. When used as directed, **ELITE PINE AWAY™** maximizes the activity and effectiveness of certain herbicides in post emergence applications. Therefore, care must be taken in treating sensitive crops during periods when plants are subjected to drought stress, high temperatures, and high humidity. **NOT FOR AQUATIC USE IN CALIFORNIA OR WASHINGTON STATE.**

DIRECTIONS FOR USE

REFER TO PESTICIDE LABEL FOR SPECIFIC CROP USE AND APPLICATION RATES. Prior to use, read and follow all direction on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label. Always add **ELITE PINE AWAY™** last to the spray mixture and provide good agitation.

USE RATES

FOR GROUND APPLICATIONS: Using at 1% v/v (25 GPA) will deliver 32 fluid ounces per acre.

FOR AERIAL APPLICATIONS: Using at 1% v/v (15 GPA) to 1.5% v/v (10 GPA) will deliver 19.2 fluid ounces per acre.

STORAGE AND DISPOSAL

Storage: Store product locked up and in original container away from pesticides, fertilizers, food and feed, and keep container tightly closed when not in use. Take care to prevent water from being introduced to the contents of this container. Keep away from sparks, flame, static electricity or other ignition sources. Shake well before use and keep from freezing. Avoid storage below 32°F. If **ELITE PINE AWAY™** is stored below 32°F, it may become cloudy and thicken. **ELITE PINE AWAY™** will return to its normal, clear fluid state above 32°F.

Disposal: Do not contaminate water, food, or feed by storage or disposal. Triple rinse container and pour rinsate into spray tank. Do not reuse container. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
