Treat symptomatically. Keep victim warm. Keep victim under observation. Symptoms may be delayed. This product is an Organophosphate (OP) Insecticide. Do not handle the patient without the following protective equipment in place: chemical resistant gloves and apron (preferably nitrile). Remove contaminated clothing and do not reuse without thorough cleaning with detergent and hot water. Dispose of heavily contaminated clothing, including shoes, as a hazardous waste. Do not wait for laboratory confirmation to treat patients with strong clinical evidence of poisoning. In the USA and other countries, contact your local or national poison control center for more information. Establish airway and oxygenation. IV Atropine sulfate is the antidote of choice against parasympathetic nervous stimulation. If there are signs of parasympathetic stimulation, Atropine Sulfate should be injected at 10 minutes intervals in doses of 1 to 2 milligrams until complete atropinization has occurred. Pralidoxime chloride (2-PAM chloride) may also be used as an effective antidote in addition to and while maintaining full atropinization. In adults, an initial dose of 1 gram of 2-PAM should be injected, preferably as an infusion, in 250 cc of saline over a 15 to 20 minute period. If this is not practical, 2-PAM may be administered slowly by intravenous injection as a 5% solution in water over not less than 2 minutes. After about an hour, a second dose of 1 gram of 2-PAM will be indicated if muscle weakness has not been relieved. For infants and children, the dose of 2-PAM is 0.25 grams. 
