DIRECTIONS FOR USE AND APPLICATION RATE

The following application rates are for GENERAL USE only. Please read and follow the label of the specific herbicide to be used with this product. Use the higher rate for hard to control weeds or weeds under stress. Protect from freezing.

Small Area Application: Use 1 to 2.5 ounces ProSolutions MSO per gallon of spray solutions. Use a suitable portable sprayer for small areas.

Acre Application: Use 1.5 to 2 pints per acre.

Aerial Application: Follow the label of the herbicide to be used with this product, including the minimum water volume per acre.

MIXING INSTRUCTIONS

Carefully read and follow directions on the label of the chemical with which ProSolutions MSO is to be used. For local recommendations, consult a competent agricultural authority or mix in this order:

1. Dry flowable chemicals
2. Wettable powder chemicals
3. Flowable chemicals
4. Water-soluble chemicals
5. Emulsifiable concentrate chemicals
6. Add **ProSolutions MSO** and continue agitation
